02. Hon. Member Nirosha Athukorala :

"Owing to the Separatist terrorism existed in Sri Lanka for more than 30 years, nearly One Hundred Thousand human lives were lost and a huge economic and social degeneration took place. As a result of the said separatist terrorism, the opportunity available for Sri Lanka to achieve the benefits of development as a prosperous country were lost and it even had to fall under the influence of foreign countries. By putting an end to that unruly era, armed forces of Sri Lanka and Police with the support of all the patriotic people of the country could defeat the separatist terrorism. This Western Province Provincial Council is in the opinion that to commemorate our patriotic heroes of armed forces who sacrificed their lives and who became disabled permanently, as well as, unarmed people of Sinhala, Tamil, Muslim ethnic groups who were faced with similar fate due to these conflicting war, 18th of May on which date the said armed terrorism was totally defeated should be named as 'War heroes commemoration date for national reconciliation' and the said commemoration should be held with dignity (M/VI/(1)/18/03) without prejudice to any ethnic community".
