"Fisheries and Aquatic Resources Statute of Western Province No. 2018"

A statute to allocate provisions for proper management of fisheries industry in coastline and internal tanks of Western Province, to take measures for welfare of fisheries community of Western Province, to supply fish and fish related products at a reasonable price for consumers of Western Province,

to establish a post of Provincial Fisheries Director in order to successfully accomplish the aforementioned affairs, to appoint an Advisory Council to maintain Fisheries affairs within the province and to allocate provisions for matters related or consequential to such.

XI. Private Members' Affairs

01. Hon. Member Gunasiri Jayanath:

"By the Bill to establish the Reparations Office, presented by Hon. Prime Minister to the Parliament, as a background where compensation to brutal terrorists will be created within a situation of allocating legal provisions to make a financial payment or provide material benefits to a person distressed by the armed conflict that took place in Northern and Eastern Provinces or as a result of it or connected to it or as an aftermath, construction of memorials and implementation memorial programmes on behalf of a person deceased owing to the above conflict, the grave disdain of this Western Province Provincial Council is expressed to the Government about this bill and the Western Province Provincial Council requests further from the Government to remove the relevant clauses of 27(b) (I), (a), instead, to include legal provisions that allocate provisions to pay compensation to people who were distressed by collapsing of Meethotamulla dump site, explosion of Salawa armed depository and natural disasters such as floods."

02. Hon. Member Sunil Watagala:

"When human lives including the total environment faced destruction by the collapse of the garbage dumps such as Bloemendhal, Meethotamulla and Karadiyana, the responsible authorities exaggeratedly stated that permanent solutions would be searched for them and action will be taken to prevent such mishaps. They said that Meethotamulla and Bloemendhal garbage dumps will be turned into urban parks. However, the said garbage dumps remain as they were. There is no long term programme. When the Kelani River overflows annually, the people inundated will be consoled temporarily by distributing among them some dry rations or a packet of rice. Therefore, this Western Province Provincial Council proposes that long term solutions should be presented by the ministries in charge of each such destruction.

03. Hon. Member Upali Kodikara:

"The number of schools for students with special needs which have been established at Zonal Education level in Western Province is around 182 and the number of students with special needs who receive education in such schools is 3713.

Although there is a student-aid system based on the results of Grade 5 Scholarship Examination is there for normal students of Government schools, also Mahapola Scholarship Programme for undergraduates; there is no student-aid system to provide for students with special needs.

Therefore, this Western Province Provincial Council is in the opinion that some allowance or aid amount should be provided to students with special needs who are studying in schools for students with special needs in Western Province to encourage such children in their education."
