  - a) Would you inform this Council as to the names of the current Chairman and Director Board of Bemmulla Vigoda SANASA Society Ltd. of Gampaha District and whether they hold a position in the Director Board or any main position in another company?
  - b) Do you know that an institution named Deegayu Land Homes is maintained by its Chairman, in his and Director Board's names, and the money of the SANASA Society has been transferred to that institution without any interest or bond?
  - c) Do you accept that the said SANASA society has faced a financial crisis owing to utilization of its deposits illegally by its Chairman?
  - d) Do you know at present, when depositors request their money, the Chairman and the Director Board refuse to give the money to them?
  - e) Would you inform the Council about what measures will be taken to provide depositors' money to them as soon as possible?
  - f) What action will be taken against the Chairman and the Director Board who deployed the said society's money to other tasks?
  - g) If not why is that?

#### XI. Public Affairs

01. The statute presented by Hon. Chief Minister and Minister of Finance and Planning, Engineering Services, Law and Order, Local Government and Provincial Administration, Economic Promotion, Electricity and Energy, Environmental Affairs, Water Supplies and Drainage and Tourism Affairs (W.P.)

"Tourist Board Statute of the Western Province No. .... of 2018"

(First Reading)

A statute to enhance the professional skills of those who engage in tourist affairs in the Western Province, provide the guidance necessary for them and support, services, improve the standards of tourist services, develop the infrastructure facilities in the vicinity of locations with tourist attraction and promote local and foreign tourist affairs of the province, establish the Western Provincial Tourist Board, repeal the Tourist Board Statute of Western Province No. 03 of 1994 and to provide provisions for the incidentals thereto.

#### 01. Hon. Yasapala Koralage - Deputy Chairman

"It is a fact known by everybody that the children studying in schools of rural areas of Western Province are severely affected by travelling difficulties. Owing to that reason, a school van culture has emerged. Therefore, this Western Province Provincial Council is in the opinion that it is suitable to provide a bicycle to school children above Grade 8 considering the economic difficulties and to alleviate the travelling difficulty of school children with a view to generate a healthy young generation for which opportunity should be allowed to allocate provisions from the criteria Based Grants allocated to Hon. Members subjected to a certain percentage."

#### 02. Hon. Member Ajantha Niroshan Padukka

"Micro finance credit is operated by institutions of the private sector in very intriguing manner in the Western Province and throughout the island.

Group loans and private loans are recovered under a 40% annual interest rate. It is a gravely unjust exploitation. As the current monitoring of the Central Bank on this credit practice is not sufficient, this Western Province Provincial Council requests from the Ministry of Finance and Central Bank of Sri Lanka to pay firm attention to this matter and immediately formulate rules and regulations to regularize these credit practices"
