"The physical resources existing in schools at present lie at a very satisfactory level. Likewise, the academic and non-academic staffs are at a satisfactory level. However, a situation prevails where it takes some time to appoint a new principal when a principal of a school retires and in many instances, the school is administered under an acting principal. Although, how well acting principals work in the post of principal, there is no opportunity for them to get permanent in that position. In a situation like this, a school, which remains at whatever advanced stage, may degenerate.

In order to evade this situation, this Western Province Provincial Council holds the opinion that a reserve of principals should be created within the Western Province either by selecting and training qualified teachers or by selecting suitable persons through principal's examinations, also, as soon as a principal of a school retires, measures should be taken to appoint a principal from this reserve in place of the retiring principal."
