By the Law approved powers of Minister of Finance, Planning, Engineering, Services, Law and Order, Local Government and Provincial Administration, Economic Promotion, Electricity, Energy, Environmental Affairs, Water Supplies and Drainage and Tourism under the 2nd sentence of the Law of Municipal Council (incidental provisions) to be read with 268th sentence of Municipal Council Audience of 252 Authority.

By Law which has being prepared by 267th sentence of Municipal Council Audience of 252 Authority by Colombo Municipal Council regarding provisions for prohibiting parking vehicles in the Administrative Limits Of Colombo Municipal Council, receiving parking space for parking vehicles, changing fees and controlling kidnapping.

I presented this by Law to the Provincial Council requesting to Western Provincial Council it should be attained under the above mentioned 2nd sentence of the Law of Provincial Council (incidental provisions) to be readout with 268th sentence of 252nd Authority of Municipal Council by Law.

Accordingly, regarding the decision taken there it is to be worked according to recommendations of Committee received about the bylaw it is discussed further in the Statutes and Laws Committee held on 18.04.2017, 25.04.2017 and 26.04.2017 by amending all sentences in the bylaw and including new sentences is recommended and a copy of by law which is mentioned above with all those recommended amendments will present as an attachment to the Statutes and Laws Committee report and was presented to thee Provincial Council held on 23.05.2017.
