1. Hon. Member Lalith Ellawala:

"As the currently Prevailing provincial Council and Parliamentary preferential election system is an election system which is difficult and problematic both to the contestants as well to the voters, the Western Provincial Council proposes to the Government that measures shall be taken to hold all the future elections for provincial councils and parliament at divisional level and seat level respectively as it has been adopted for the new local government election system." 2. Hon. Member Sirikamal Felician de Silva :

"Stating that to minimize the annual loss incurred to the Sri Lanka Electricity Board, the electricity bill was increased from last April to recover the said loss by charging from the public. 'Due to scarcity of rain-reception and resultant drying up of reservoirs, 18% of the country's electricity demand had to be met up with hydro electricity whereas purchasing electricity at high price from private hydro-power generators as well as electricity production by other methods too was needed'; it was stated. Owing to the heavy rains experienced within the last few months, the reservoirs have brimmed up and 85% of electricity is produced by hydropower plants. Therefore, this Western Province Provincial Council proposes to the Government to immediately bring down the increased electricity bill and provide relief to the public." (M/v(01)13/05)
