01. Hon. Member Ashoka Lankathilaka

"The physical resources existing in schools at present lie at a very satisfactory level. Likewise, the academic and non-academic staffs are at a satisfactory level. However, a situation prevails where it takes some time to appoint a new principal when a principal of a school retires and in many instances, the school is administered under an acting principal. Although, how well acting principals work in the post of principal, there is no opportunity for them to get permanent in that position. In a situation like this, a school, which remains at whatever advanced stage, may degenerate.

In order to evade this situation, this Western Province Provincial Council holds the opinion that a reserve of principals should be created within the Western Province either by selecting and training qualified teachers or by selecting suitable persons through principal's examinations, also, as soon as a principal of a school retires, measures should be taken to appoint a principal from this reserve in place of the retiring principal." 02. Hon. Member Ashoka Lankathilaka

"Different projects are being implemented by the current Government to develop agriculture within the country. A high vegetable and fruit crop yield is being received under the projects like "Api Wawamu, Rata Nagamu", "Divi Neguma" and "Provision of Fertilizer Subsidies". During the time of harvest, vegetables and fruits can be obtained at reasonable prices and during those times certain instances where the excess crop is left to decay without being utilized can be seen. That situation affects adversely to the farmers, consumers as well as to the total economy of the country. Therefore, this Western Province Provincial Council is in the opinion that measures should be taken to prepare methodologies to preserve food crops and by introducing them to the farmers to prevent the loss created to the farmers and to provide opportunity to consumers to purchase products at a reasonable price."
