X. Private Members' Affairs

01. Hon. Member Ashoka Lankathilaka :

"Different projects are being implemented by the current Government to develop agriculture within the country. A high vegetable and fruit crop yield is being received under the projects like "Api Wawamu, Rata Nagamu", "Divi Neguma" and "Provision of Fertilizer Subsidies". During the time of harvest, vegetables and fruits can be obtained at reasonable prices and during those times certain instances where the excess crop is left to decay without being utilized can be seen. That situation affects adversely to the farmers, consumers as well as to the total economy of the country. Therefore, this Western Province Provincial Council is in the opinion that measures should be taken to prepare methodologies to preserve food crops and by introducing them to the farmers to prevent the loss created to the farmers and to provide opportunity to consumers to purchase products at a reasonable price." 02. Hon. Member A.M. Yoosuf :

"Eventhough the hospitals currently functioning within the provincial council authority of the Western Province have been subjected to categorization, attention has to be paid to their quality status. Especially, people living in the Kalutara district in areas of Mathugama, Agalawatte, Walallawitawhere hospitals exist at divisional secretariat level, are low income receivers and those areas are remote areas with harsh living conditions. Therefore, this Western Province Provincial Council proposes that attention should be paid to upgrade the hospitals of those areas having taken into consideration about the remoteness and harsh living conditions of those areas."
