"Whereas, the Hon. Governor of the Western Province having referred the Parliament of Democratic Socialist Republic of Sri Lanka- Divineguma Bill , has communicated by the letter dated 19.09.2012 that a statement of expression of this Western Province Provincial Council regarding the aforementioned bill as per Paragraph (3) of Clause 154 (g) of the 13th Amendment to the Constitution be submitted to him prior to 28.09.2012 so as to be referred to His Excellency the President; and according to the prior discussion conducted at the Business Advisory

Committee Meeting of 19.09.2012 in relation to that matter, the proceedings of this council today under the subject of Public Affairs in the Agenda with regard to the said bill shall proceed considering that no impediment whatsoever shall arise from provisions stated in Rules of Procedure Rule Nos. 15(1), 15(4), 57(1), 57(3), 57(4), 57(5), 63a(2), 63a(3), 88(2) and 88(3).”
