"It is said that Sri Lanka is a country where free education is implemented. Nevertheless, we know that there is an established school system consisting of Central Government, Provincial Council, Private and International schools. From among these, majority of schools belong to Provincial Councils. This Provincial Council allocates a major portion as a percentage from its annual budget statement to the Ministry of Education, which is represented by the Chief Minister. However, due to the reason of authorities themselves stating that the annually allocated money for the maintenance of schools of our province is not sufficient, it is no secret that the shortages existing in schools are met with the assistance of parents, students, well-wishers and through other methods. Thus, this Western Province Provincial Council intends that a proper mechanism should immediately be set up in order to avoid the inconveniences faced by parents and students due to this irregular process,"
