  - a) Do you accept the fact that the Kelaniya Multipurpose Cooperative Society, without holding an election , functions for 6 years under a Chairman named by the Commissioner of Cooperatives?
  - b) Do you accept the fact that the Chairman appointed thus is not a member of this society?
  - c) Do you accept that this appointment has been made on political affinity?
  - d) Do you agree that many critical financial irregularities have taken place in the Cooperative Society under this Chairman?
  - e) Do you accept the fact that action is not being taken with regard to the said forgeries and corruptions, which have already been reported through certain persons and organizations, due to political affinities?
  - f) Would you, as the minister in charge, take certain step to protect the cooperative society, which is deteriorating day by day?

  - b) Due to that reason, when the Cooperative Board has informed that it is giving an annual interest of 16.25%, by depositing the Society's money worth Rs. 375 Lakhs under an interest of 15.25% in Gampaha District Cooperative Rural Bank and Rs. 150 Lakhs under an interest of 16% in the Colombo District Rural Bank Association, do you know that the Society lost Rs. 412,500/= worth interest annually?
  - c) Do you accept the fact that by depositing the deposit money of Gampaha District Bank Association in the Sri Lanka National Cooperative Board in year 2012 on Chairman's discretion and under the decision of the Board of Directors, an additional interest of Rs. 468,750/- was received?

  - 1. Hon. Member Sirikamal Felician de Silva:

"It is said that Sri Lanka is a country where free education is implemented. Nevertheless, we know that there is an established school system consisting of Central Government, Provincial Council, Private and International schools. From among these, majority of schools belong to Provincial Councils. This Provincial Council allocates a major portion as a percentage from its annual budget statement to the Ministry of Education, which is represented by the Chief Minister. However, due to the reason of authorities themselves stating that the annually allocated money for the maintenance of schools of our province is not sufficient, it is no secret that the shortages existing in schools are met with the assistance of parents, students, well-

wishers and through other methods. Thus, this Western Province Provincial Council intends that a proper mechanism should immediately be set up in order to avoid the inconveniences faced by parents and students due to this irregular process,"
