1. Hon. Member Ajantha Niroshan Padukka

"Western Province Solid Waste Management Authority, for the past seven years, has been incapable of successfully implementing the control, collection, disposal of garbage and solid waste of Western Province as well as production of electricity and compost manure as byproducts of the said process.

Within this period, the requirement for implementing this process, which is a major and essential process of the province, in more effective and efficient manner, has been felt by the whole province.

Therefore, to strengthen more the town development process carried out by the Urban Development Authority at present, this Provincial Council is in the opinion that in collaboration with the Urban Development Authority of the Central Government which has strong finances and technology to implement such projects; short term and long term plans limited to certain time frame should be planned and implemented."

2. Hon. Member Mahesh Almeida

At present we see the children of school attending age of the Western Province are afflicted by various diseases and suffering in large numbers. The main reason affecting this situation is bad health habits and abnormalities in behavior systems. As a result, children get afflicted by non-contagious diseases commonly and largely.

Similarly, children are commonly affected by deadly Dengue fever and it has become evident that our lack of interest to keep the environment cleanly has caused this situation. Considering all these situations, as a step towards saving the children from these diseases and suffering, this Council proposes that having established Health Societies in schools by Western Provincial Education Ministry and Health Ministry in collaboration, to mediate through a legal framework for matters like raising awareness in children, providing medicine and instructions on illnesses and cleaning the environment."

01. The statute presented by the Hon. Minister of Agriculture, Agrarian Development, Minor Irrigation, Industry, Environmental Affairs and Cultural and Arts Affairs (W.P.)

"Minor Irrigation Statute of the Western Province No. ... of 2013"

(First Reading)

A statute for the construction, rehabilitation and maintenance of minor irrigation work including planning, designing, implementation of all minor irrigation work in the Western Province other than irrigation schemes relating to rivers running through more than one province or interprovincial irrigation and land development schemes.

The provisions of this statute are inconsistent with the Irrigation Ordinance (Chapter 453).
