#### 01. Hon. Member Mahesh Almeida:

"A large number of people live in estate related areas in Western Province and a large number of estate schools have been established with the objective of making better the lives of children of estate people and transform such children into strong partners in the country's economy. Even though a lot of facilities have been allotted to ensure reception of proper education by these children who are studying in estate schools, the teachers teaching in them are facing many difficulties.

Among the difficulties faced by such teachers, the main difficulty is transportation available for them to reach the said schools. As a solution to it, this Provincial Council is in the opinion that measures should be taken, by the intervention of the Western Province Provincial Council, to provide a motorcycle to all the Teachers and Principals of estate schools to facilitate their transportation affairs."

## 02. Hon. Member Rose Fernando:

"The right to proper school education by clever students born in low income earning families in villages is being disinherited by gradual closing down of village schools by introducing various names and programmes. It is observed that the students who cannot travel to far away schools through vehicles tend to drop out of school education as a result of closure of village schools. Owing to this situation, parents are faced with various difficulties. Therefore, this Western Province Provincial Council is in the opinion that the education rights of village students should be safeguarded by providing facilities again to village schools."
