"The main obstacle cropped up against creating a healthy and virtuous Sri Lankan society devoid of narcotics is, responsible persons of society and politicians assisting in alcohol and drug related activities. Therefore, this Western Province Provincial Council, as a responsible Provincial Council shall take action to create a healthy younger generation, a better future, virtuous society devoid of narcotics as well as good governance, also, to reduce the demand in society for alcohol and drugs while dissuading the persuasion towards it. To achieve that, as this Provincial Council is in the opinion that the peoples' representatives and responsible persons of society shall specially function without connections to trades relating to alcohol and drugs, and, if there are such connected persons, they shall be punished without considering their rank, in order to remove alcohol and drugs from our country strict laws should be imposed to stop them being brought into the country and against their use; this Western Province Provincial Council requests from the Government including His Excellency the President and Prime Minister to take action in that regard and thereby take action to impose severe punishments if responsible persons of society, politicians are engaged in trades linked to alcohol and drugs."
