X. Private Members' Affairs

01. Hon. Member Nishantha Sri Warnasinghe:

"As a result of speedy growth in consumerism triggered by the introduction to open economic trade in Sri Lanka, the waste disposal amounts increased speedily. In such waste disposed, non-biodegradable lunch sheets, shopping bags, polystyrene and polythene collected largely and owing to that, this became a reason to delay the decay of biodegradable waste and it affected the environment, society, human existence as well as other animal species multifariously wherein accumulation of non-decaying waste led to mountainous garbage dumps resulting in a huge tragedy and loss of lives.

The decision taken by the Government led by His Excellency the President prohibiting production, selling and use of lunch sheets, shopping bags, polystyrene and polythene as they make major delay and obstructions as well as cause destruction to the processes of waste disposal, decay, recycling and compost production; is hereby appreciated and praised as an effective policy decision taken for country's future generation and environment. While proposing to this Western Province Provincial Council that it shall extend its support to implement this polythene prohibition and to implement the law relevant to it on behalf of the country and requesting from the government that these policies shall not be reversed due to whatever an influence, whereas, immediate action be taken to promote environment friendly alternatives and substitutes and to popularize them among the public".

02. Hon. Member Rose Fernando:

"Political parties of both Right Wing and Left Wing of this country strongly discussed that the Constitution of Democratic Socialist Republic of Sri Lanka shall be changed and serious demonstrations occurred in the country requesting to annul the Office of Executive Presidency. Under this situation, during the previous election campaigns promises were made to form a Constitution suitable to the country and to assign to Parliament the unlimited powers enjoyed by the Executive Presidency's Office. Even though none of the previous Presidents who promised to annul the Executive Presidency accomplished those promises, current President taking action to annul the 18th Amendment to the Constitution that allowed reigning in power extensively, was some positive feature. At this juncture, when a meaningful dialogue is going on to establish a new Constitution by collaborating all the parties as current President and Prime Minister promised to the public, this Western Province Provincial Council proposes to the government; by discarding narrow political attitudes, all the people should be brought together to form a Constitution suitable to the country."
