The Law College at present has become a place that takes arbitrary decisions without following the rule of law. The persons holding highest responsibilities in this field have turned out into persons who violate basic human rights of law students. There is no institution for the students to complain with regard to this situation neither can they go to courts.

Hence, it is the duty of the Government to preserve the dignity of Law College which, within such a situation, completes 100 years of functioning and hand it over to the future generation. Therefore, this hounourable Council of the Western Province proposes to the Government that the currently existing undignified situation of the collapsing Law College should be solved immediately to mete out justice to the students of the Law College who are facing serious injustices.
