  - II How much is that amount?

**Motion:**

**Amending the Limits of Provincial Council Advance Accounts according to  
Section 07 of the Appropriation Statute No. 06 of 2013 – year 2014**

“As stated in the Schedule; ‘Amending the Limits of Advance Accounts – 2014’, since action has been taken as per provisions of Section 07 of the Appropriation Statute No. 06 of 2013 when limits of Advances are amended; and

as the Provincial Board of Ministers’ approval has been received subjected to Council approval to execute the said amendments,

this Western Province Provincial Council does hereby approves amendments to the limits of each Advance account as stated in that Schedule.”

## **X. Private Members' Affairs**

### **1. Hon. Member Mahinda Jayasinghe:**

“At present, within the Western Province, fees are being charged from school children and parents from time to time. Collecting money from children’s parents when children are enrolled to Grade One, Grade Six and Grade Twelve as well as for other requirements in classes have put them in greater difficulties. Therefore, this Western Province Provincial Council holds the opinion that levying fees (except Facilities Fees) from school children’s parents of the Western Province should be suspended.” (M/vi (01)/14/09)

### **2. Hon. Member Lakshman Nipuna Arachchi:**

“Being a process that oppress children and parents both, there is a necessity to change the present procedure followed in enrolling students to Grade 1 in Western Provincial schools. To achieve that, this Western Province Provincial Council holds the view that filling all the vacancies prior to elapsing of one month from the date of children’s enrollment to schools, by making the Provincial Council receive the name list of children of persons employed in Security Forces prior to elapsing of 3 weeks from the date of children’s enrollment to schools, cancelling the enrollment of children according to the list presented by ruling party members, preparing a permanent register in chronological order according to the marks received by each child participating in the interview and taking measures to enroll children to schools according to the order of marks received by them should be implemented and thereby enrollments to Grade 1 in schools of Western Province should be regularized, while, ensuring at the same time for the people of the Province the human right that should be there to enroll a child to a school.” (M/vi (01)/14/10)
