Regulations under Pawnbrokers' Statute of the Western Provincial Council No. 01 of 2015

"Regulations cited as the 'Regulations under Pawnbrokers' Statute of the Western Provincial Council No. 01 of 2015";

drafted under the powers vested as per Section 53 of the Pawnbrokers' Statute No. 01 of 2015 of the Western Provincial Council to the Chief Minister of Minister of Finance and Planning, Engineering Services, Law and Order, Local Government and Provincial Administration, Economic Promotion, Electricity and Energy, Environmental Affairs, Water Supplies and Drainage and Tourism Affairs, and,

published in the Extraordinary Gazette [Part IV(A)- Provincial Councils] of the Democratic Socialist Republic of Sri Lanka No. 1937/20 dated 22nd October 2015,

have been presented to this Provincial Council on 28.12.2015 for approval as per Sub-section 53(4) of the same statute, and, as per the decision taken therein on the said date and having further discussed at the Committee on Statutes and Laws held on 24.03.2016; the report containing recommendations of that committee was presented to this Provincial Council on 05.04.2016, hence, proceedings shall be taken by considering the recommendations of the said Committee."

"As stated in the Schedule of 'Amending the Limitations of Advance Accounts – 2015', since action has been taken in accordance to the provisions of Section 07 in the Appropriation Statute No. 06 of 2014 while amending the advance limitations, and;

X. Private Members' Affairs

01. Hon. Member Lalith Ellawala

"His Excellency the President Maithripala Sirisena's new government making plans by appointing committees to punish through law the offenders who are responsible for corruption, forgeries homicides, misusing of state property; alleged to have been committee during the previous government, is an appreciable matter.

There is no other time in recent Sri Lankan history than the period of 1989 -1990 during which time killing of people took place amidst destruction of state property at large. Therefore, this Western Provincial Council requests from His Excellency the President to take action to appoint a committee to investigate into such destructions and punish through law the persons who destroyed state property and carried out human killings as well as to recover from responsible persons the value of state property destroyed."

02. Hon. Member Mahinda Jayasinghe:

"Enrollment of children to schools has escalated into a very critical status.

Although a formal procedure is in action to enroll children to Grade One and Grade Six in comparison to the process of enrolling children to other Grades, such a formal procedure is not in practice to enroll children to other Grades. It is learnt that accepting various bribes, corruption, various irregularities have cropped up as a result.

Therefore, this Western Province Provincial Council is in the opinion that a request should be made from all the relevant parties to establish a more formal procedure for enrollment of children to other Grades as is the procedure followed at present with regard to enrollments to Grade One and Grade Six, and, to take measures to implement it in Western Provincial Council schools."
