 - (II) If so, can a complete report be presented in that regard?
 - (III) If not, what is the reason for it?
 - (IV) Do you know that evidence had not been called from the person, who served as the Manager at that time, whose evidence is considered as main evidence, in the 47(1) investigation?
 - (V) Likewise, are you aware that a report about the cash in hand, which is considered to be compulsory evidence, has not been presented?
 - (VI) If so, has the 47(1) investigation greatly prejudiced owing to the facts revealed by the above said question No. (IV) and (V)?

- b) (I) Has the Committee at that time made an offence under sections of 4-5-1, 4-7-3 of the registered bylaw of the Society and under Section 26 of the Cooperative Society Regulations of 1973?

 - b) Would you inform to this Council whether a valuation report on the condition of the building has been obtained through a Technical Officer by the Deputy Commissioner of Gampaha before proceeding into further affairs of the said investigation under 47(1)?
 - c) Do you accept the fact that a letter has been referred on 06.08.2008 to the Divisional Engineer's Office by the Deputy Commissioner of Gampaha to obtain the valuation report on the condition of the said building?

- a) Would you inform to this Council in detail whether a problem has arisen regarding a loan application which was incomplete and has not been approved by the Credit Committee with regard to matters resulted in suspension of the Internal Audit Committee of "SANASA" Society of Kochchikade, Negombo?
- b) If so, what is the name of the Officer of the Committee who owns the said loan application?
- c) How much is the loan amount issued? Is it lawful? And do you accept the fact that obtaining the said loan is like enjoying an illicit privilege?
- d) Would you inform to this Council whether any other measure has been taken to fill the lacuna created by the inability to function in relation to certain sections of the bylaw due to the suspension of the Audit Committee for months? And what action will be taken against the Committee members who have breached the bylaw?
- e) If not, why is that?

- d) When exporting seeds from foreign countries to this country, are they subjected to standardization tests?
- e) Does your ministry, as the Western Province, possess facilities which can be utilized to organize an immediate programme to protect crops from menaces such as these?
- f) Would you arrange for a system in future to face such menaces, which require immediate action?
- g) If not, why is that?

- b) Are you aware that buildings have been constructed, obstructing minor irrigation systems that provide water to agricultural cultivations, in certain areas?
- c) Have the plans relating to these minor irrigation systems been identified by your ministry and been Gazetted?
- d) In which year has the irrigational plans been surveyed, which has the boundaries marked properly and can be referred to in cases where obstructions to canal-ways or minor irrigation systems are detected?
- e) From which officer of your ministry from whom the surveyed plan could be obtained in case any matter arises with regard to said irrigations or canal-ways?
- f) When will a programme be implemented to prepare plans on such minor irrigations and canalways, to Gazette as well as to preserve them?
- g) If action will not be taken accordingly, why is that?
