#### X. Private Members' Affairs

#### 01. Hon. Member Upali Kodikara:

"The number of schools for students with special needs which have been established at Zonal Education level in Western Province is around 182 and the number of students with special needs who receive education in such schools is 3713.

Although there is a student-aid system based on the results of Grade 5 Scholarship Examination is there for normal students of Government schools, also Mahapola Scholarship Programme for undergraduates; there is no student-aid system to provide for students with special needs.

Therefore, this Western Province Provincial Council is in the opinion that some allowance or aid amount should be provided to students with special needs who are studying in schools for students with special needs in Western Province to encourage such children in their education."

#### 02. Hon. Yasapala Koralage - Deputy Chairman:

It should be mentioned that the public have been greatly pressurized owing to the education policy in practice at present. There is a method to gradually reduce the number of students per classroom from 45 to 35. Presently, 07 children per class have been cut off. The education authorities do not understand that a conflict in society has arisen due to not starting at least one new class in schools to house the students cut-off from a class. Therefore, this Western Province Provincial Council is in the opinion that immediate attention to this matter should be paid and a number of new classrooms proportionate to house the afore-said numbers of students (who were cut off from each parallel class of a school) should be started in every Education Division.
