### Supplementary Estimate 03 of 2018

"In order to provide additional allocations for year 2018 for the under-mentioned requirements in the institutions of Western Province, i.e.;

- <u>Department of Health Services</u>
  - *i.* Additional provisions required for year 2018 to pay salaries and allowances for new recruitments in the health sector, promotions and transfers obtained to the department.
  - *ii.* Additional provisions required for year 2018 to pay Overtime according to rates increased by promotions and as per circulars issued by the Line Ministry.
- <u>Department of Ayurveda</u>
  - *i.* Additional provisions required for year 2018 for salaries, allowances for new recruitments and transfers to Ayurveda Department and telecommunication services.

  - *i.* Additional provisions required for year 2018 on behalf of bearing grant based expenses received from the Government for the project of "Converting the School Education to be the basis of Knowledge Hub"

  - *ii.* Requiring to pay additional Holiday Pay for the Divisional Engineers and Technical Officers as a large amount of additional work had to be carried out in construction affairs to be performed as per Supplementary Estimate proposals.

#### Appropriation Statute relating to the Supplementary Estimate 03 of 2018

#### 01. Hon. Yasapala Koralage – Deputy Chairman :

A fact known by everybody is that students studying in schools of rural areas in the Western Province face grave travelling difficulties. A school-van culture has rooted up as a result. Therefore, this Western Province Provincial Council is in the opinion that a bicycle should be provided to children above Grade 8 considering the economic hardships and with a view to eliminate school children's travelling difficulties as well as to generate a healthy younger generation, for which opportunity should be provided to allocate provisions under some percentage from the funds allocated to Hon. Members through Criteria Based Grants provided to them. (M/VI/(1)/18/07)

#### 02. Hon. Member Ajantha Niroshan Padukka :

"Provision of micro-finance credit by private sector institutions is in operation in an intriguing manner within the Western Province including the whole island.

Group credit and private credit is being recovered under an annual interest of 40%, which is a gravely unjust exploitation. As the Central Bank's monitoring on this credit system is not sufficient currently, this Western Province Provincial Council requests from the Ministry of Finance and Central Bank of Sri Lanka to pay firm attention to this situation and formulate and implement speedily new laws and regulations to regularize these credit systems."
