- d) Would you inform to this Council whether you accept the fact that the salaries paid currently to the said officer is a misuse of public money? If such a situation prevails, what action will be taken regarding that?

short period of time such as 5 years into the recruitment procedure, contrary to the instructions in the recruitment procedure?

- d) Would you inform to this Council what action has been taken by you to remove the salary anomalies of Trainers who do not take action to be recruited as Sports Trainers?
- e) If not, why is that?

- c) Due to the said person's defaulting of loan repayment, do you know that the property kept as security had been auctioned and loan has been recovered?
- d) Do you know that the said property valuated as Rs. 2,165,600/- has been purchased at a cost of Rs. 1,300,000/- after placing a bid of Rupees Nine Hundred Thousand by a Cooperative Director of the same Cooperative Society named M.M. Stephen Paris who participated in the said auction to which no other external person participated?

As the current monitoring of the Central Bank on this credit practice is not sufficient, this Western Province Provincial Council requests from the Ministry of Finance and Central Bank of Sri Lanka to pay firm attention to this matter and immediately formulate rules and regulations to regularize these credit practices" (M/VI(1)/18/08)
