- 01. Hon. Member Sirikamal Felician de Silva :

"Stating that to minimize the annual loss incurred to the Sri Lanka Electricity Board, the electricity bill was increased from last April to recover the said loss by charging from the public. Due to scarcity of rain-reception and resultant drying up of reservoirs, 18% of the country's electricity demand had to be met up with hydro electricity whereas purchasing electricity at high price from private hydro-power generators as well as electricity production by other methods too was needed'; it was stated. Owing to the heavy rains experienced within the last few months, the reservoirs have brimmed up and 85% of electricity is produced by hydropower plants. Therefore, this Western Province Provincial Council proposes to the Government to immediately bring down the increased electricity bill and provide relief to the public." (M/v(01)13/05)

#### 02. Hon. Member Ashoka Lankathilaka :

"We, the Sri Lankans, who were unable even to think about the future having being tormented by a cruel war, can be happy about the development processes that have been implemented in this country today.
